Coworkers – Beau and Luke Duke:

- Bo and Luke Duke are the best of friends at work. They share a workstation.
 They eat lunch together. They spend time outside of work together.
- They each have toolboxes.
- Bo has pictures of his family taped up all over his workstation and in his toolbox are stickers of his favorite heavy metal radio station.
- Similarly, Luke has pictures of his family. Luke is from the deep South and loves country western music and the South is in his blood. In addition to various southern radio station decals, he has a picture of the General Lee from his favorite television show. The top of the car is prominently displayed. He also has a bunch of other car decals.
- They are tucked away on the shop floor and it is rare that anyone outside of other employees goes in their area.

- They are great employees. Bo is African-American; Luke is Caucasian.

- What if Luke experiences marital problems and replaces his wife's pictures, with Daisy's bikini pin-up (she quit working at the local tavern and has taken to modeling).



Coworkers - Masked Crusaders:

- In 2020, ABC Corp. implemented a mask requirement policy in response to COVID
- ABC Corp. was an essential employer providing needed services during COVID
- At first, folks were lucky just to get masks with the supply shortage.
- The majority of employees initially wore paper masks.
- Then the mask market boomed. Folks started showing up with bejeweled masks, masks with smiley faces, dog faces, rainbows, etc.
- The company even made its own ABC logo masks and handed them out to employees.
